## Preamble

Mr. Speaker Sir, Today marks another beginning of the long journey of Five Years. Its required that entities approve their Fourth Five Years Development for FY2025/26 - 2029/30. The proposed investments were tabled before council for scrutiny.

Mr. Speaker I hereby propose that the District 5 years Investment be approved by council before approval of Budget for FY2025/26.

Mr Speaker, in fulfilment of Article 155(1) of the Constitution, I have been delegated by District Chairperson to present to this August House , the Budget for the Financial Year 2025/2026. This exercise followed the laying of District Budget in March 2025 and thereafter Committee discussions Mr. Speaker Sir, Section 77, Sub-section 1-5 of the Local Governments Act CAP 243, further emphasizes that council approves estimates of revenue and expenditures for each financial year

I am accordingly performing this duty on behalf of the District Chairperson in the capacity of the Secretary Finance, Planning, administration and Investments.

The theme for the National Budget is “**Full monetization of the Uganda Economy through Commercial Agriculture, Industrialization, Expanding and Broadening Services, Digital Transformation and Market Access**”. This is consistent with the National Vision

Socio-economic transformation for the benefit of all people living within the district and thus improve their lives. We must therefore quickly accelerate the economic recovery that integrate more Ugandans into the money economy, and speed up growth in the country’s productive sectors.

Mr Speaker, in this Budget Statement, I will Highlight the revenue and expenditure framework for the next Financial Year 2025/26,

Mr. Speaker Sir, During the laying of Budget in March 2025, the IPF was UGX. **30,073,321,373**=from various sources but this has slightly changed an shown below.

- Other Government Transfers like UWA
- Donor funds supporting Health Sector
- Increase in LoCAL funds and introduction of Physical Planning Grant
